

# October 20, 2022 HPRS Board Meeting

### Highlights

The Highlights correspondence is aimed at providing timely information to our membership about HPRS meetings, since board minutes cannot be approved and posted until after the next board meeting. Below are the highlights from the October 20, 2022, HPRS Board meeting.

#### **Administration Committee**

The board passed a motion to set the 2023 employee contribution rate at 13%. The board also approved a 3% Cost-Of-Living Adjustment for eligible members.

#### Health, Wellness, and Disability Committee

The board approved a Wellness Policy that provides a Screening or Wellness Examination to all eligible retirees and spouses. The most significant change is to provide the benefit to all retirees and spouses regardless of whether they receive their health care benefit from HPRS. Additionally, the VISA Gift Card program will continue through 2023.

#### **Health Care Funding Committee**

The board passed a motion to make a \$3.89 million allocation to the health care fund for 2022. The board also approved a vision plan design change that will provide an eyeglass/contact benefit once every 12 months instead of the current coverage of once every 24 months. The vision plan premiums will increase in 2023. For retirees and surviving spouses, the premium will increase to \$8 per month. The premium for a spouse or for children will increase to \$10 per month.

#### **Total Fund Update**

One of the most important responsibilities of the board is making investment decisions. Investment returns are critical to the viability of our system, as they provide for more than 2/3 of the benefits paid. The board spends a considerable amount of time working with its investment consultant planning, researching, and discussing ways to enhance our portfolio. Year-to-date returns show an estimated loss of 12.6% as of October 18<sup>th</sup>. HPRS assets are currently at approximately \$962 million.
