Proceedings:

- At 9:37 a.m., Anderson called the meeting to order, and the roll was called.
- Motion: To approve the minutes of the December 19, 2024 meeting, (motion by Them; second by Warnimont; motion carried unanimously.)
- Roark presented the Investment Committee Charter and 2025 Work Plan and advised there were only minor changes.
- Motion: To approve the Investment Committee Charter and 2025 Work Plan as presented by staff, (motion by Anderson; second by Warnimont; motion carried unanimously.)
- Blake briefly reviewed the 2025 Oversight Dashboard.
- Blake gave a capital markets update.
- Blake presented the December 2024 flash report and reviewed performance as of December 31, 2024; the total plan was up 9.6%, with most private strategies yet to report 12/31 performance. He also presented a portfolio snapshot as of February 18th and estimated the fund was up 2.4% year-to-date with assets of \$1.166 billion.
- Guyuron presented a private equity cash flow analyses and asked that a group be established to monitor private equity and evaluate future opportunities.
- Anderson, Warnimont, and Press were selected.
- Guyuron gave an update on the Silver Point Specialty Lending Fund conversion.
- Motion: To authorize the Chief Investment Officer to opt-in to the private BDC structure of the Silver Point Specialty Lending Fund, (motion by Warnimont; second by Allen; motion carried unanimously.)

- Roark presented two Statements of Investment Beliefs from other systems as examples for HPRS, (for discussion) asking for feedback from the committee.
- Discussion ensued.
- The committee and staff will research and bring suggestions to the next meeting.
- Roark presented a Board Smart talk: Investment Beliefs.
- Discussion ensued.
- At 11:10 a.m., Anderson declared the meeting adjourned.
