- Blake briefly reviewed the 2025 Oversight Dashboard.
- Blake gave a market update.
- Guyuron reviewed performance as of August 31, 2025 and a portfolio snapshot as of October 14th. He estimated the fund was up 9.9% year-to-date with assets of \$1.224 billion.
- Guyuron gave a private credit review and asked that a group be established to evaluate future opportunities in 2026.
- Anderson, Warnimont, and Press were selected.
- Anderson declared a break at 10:20 a.m.
- The meeting was reconvened at 10:34 a.m.
- Anderson turned the floor over to Diamond Hill.
