Pre-Medicare HRA Project Debrief

The transition to a Pre-Medicare Health Reimbursement Arrangement (HRA) is complete. However, there are some retirees that have not opted-in to the Pre-Medicare HRA and are not taking advantage of this benefit. As a reminder, even if you have access to health care (through current employer or spouse) you are still eligible for the Pre-Medicare HRA. The HPRS Pre-Medicare HRA is an open model, meaning that you are eligible for the benefit regardless of where you access health care, but you must take action and opt-in. The only exception is for those that used tax credits for reduced monthly premiums. You cannot use both the HRA and tax credits. Retirees that have not acted are encouraged to engage with Via Benefits immediately to get the HRA account in place.

Overall, the final transition of members that accessed medical and prescription drug coverage through HPRS to an HRA went well. Many that were concerned about expensive monthly premiums were able to qualify for tax credits that significantly reduced their premiums and chose that option over the HRA. About 2/3 (67%) of retirees chose a Bronze Plan, while 20% chose Silver, and 13% went with Gold. For more about plan levels, go to https://www.healthcare.gov/choose-a-plan/plans-categories/.



Reimbursement Education

If you have opt-ed-in to the HRA, you should receive a Reimbursement Guide in the mail, which provides information on how to get reimbursed, and what you can be reimbursed for. If you did not receive the guide in the mail, you can also view it on our website.

Members are encouraged to use the Via Benefits phone app. Reimbursement requests can be submitted by taking a picture of the receipt and completing basic information for the request. The status of the reimbursement request is available on the app, as well as current HRA balance, etc. Additional information on the Via Benefits mobile app is in the Reimbursement Guide.

Tax Documents Mailed to All Benefit Recipients

The IRS 1099-R Form for 2023 was mailed to all benefit recipients on January 12, 2024. This document can also be printed from our website, after logging in to the secure member area. Additionally, you should expect to receive a 1095-B from your health care provider. As a reminder, tax withholdings can be changed by logging in to the member area of the website.

Most months result in a pension payment on the 20th of the month. However, when the 20th of the month falls on a weekend or Holiday, the pension payment will occur on the next business day. This will occur five times in 2024, for the following dates: January 22nd, April 22nd, July 22nd, and October 21st.

Retiree Qualification

The Academy Range will be hosting annual retiree qualifications in 2024. As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C: Carrying of concealed firearms by qualified

retired law enforcement officers. For example, if you qualified on May 1, 2023, then you must qualify on or prior to May 1, 2024.

The upcoming scheduled retiree qualifications at the Academy for 2024 are:

- Wednesday, April 3, 2024, at 1300 hours
- Friday, June 21, 2024, from 0900-1030 hours (Annual Retiree Cookout)
- Wednesday, August 7, 2024, at 1300 hours
- Wednesday, October 9, 2024, at 1300 hours

Additionally, all retirees may also reach out to their local District Headquarters for local weapons qualification availability.

You must complete a Weapons Qualifications Record (HP-15C), that includes your personal weapon information, and submit it to Melissa Fellure at mjfellure@dps.ohio.gov no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition.
