<u>Pre-Medicare Health Reimbursement Arrangement</u> <u>Project Update</u>

As a reminder, this project pertains only to the Pre-Medicare (under age 65) Health Reimbursement Arrangement (HRA). Any changes that may occur to the Medicare HRA for 2024 will be decided in August, after receiving the actuarial report.

During the month of July, HPRS staff members and trustees provided informational sessions at all District Headquarters, as well as various other locations in Ohio. These events aimed at accomplishing three main objectives: explain the need for the change to an HRA, give an overview of how the change will impact our members, and answer questions related to the change.

A Zoom meeting was conducted on July 6th that provided the same informational presentation, which had 85 logged in at one point. This Zoom session was recorded and posted to our website where it can be viewed at any time. Moreover, the slide presentation that was shown is on the HPRS website.

In late August, the official announcement letter will be mailed out that will have the website information for Via Benefits, and a dedicated phone number for our members to opt-in to the HRA. For those that need to access health care from the marketplace, the 2023 plans can be viewed at this time to price and compare. Note the 2024 plans will not be available until November 1st.

The timeline for the remainder of the HRA process is:

- Sept. 12th and 13th, at 10A and 2P each day, there will be a live webinar to learn more about the HPRS Pre-Medicare HRA, and about Via Benefits and their resources.
- Sept. and Oct Pre-enrollment Sessions with Via Benefits for those that may want to purchase medical coverage. Members can opt-in to the HRA, so that they have access to the reimbursement allowance starting in January.
- Nov. 1 Dec. 15 Enrollment Period.
- December and January Education on how to get reimbursed from your HRA.
- January 2024 HPRS Pre-Medicare HRA allowance becomes available.

Is a Trust Right for You?

It is not always our favorite subject to discuss, but it is important that all of us take the proper steps to ensure everything is in order in the event of our death. As such, in the past we have recommended that active and retired members consult an attorney for wills and powers of attorney. Several of our members have also created a family trust or some other sort of

trust to aid in the estate process. Whether or not a trust is a good idea is an individual decision based on specific circumstances of each active member or retiree. A trust may be named as a beneficiary for certain benefits such as DROP contributions and lump sum death benefits. Even if you decide a trust is not ideal for you, we encourage all active and retired members to periodically review and update their beneficiary forms.

Lower Prescription Drug Costs

Over the last several years, we have reported on the success of our members lowering their prescription drug costs. Ways to save include the use of a discount prescription card (such as Good Rx) or mail-order pharmacies (such as Cost Plus Drugs and Amazon Prime). Keep in mind, if you use a discount Rx program instead of



your Medicare coverage, your out of pocket costs will not count towards your Part D TROOP (true out of pocket). Medicare-eligible members with a prescription plan purchased through Via Benefits should consult with their Benefits Advisor to ensure they are making the best decision to achieve the lowest annual expenses.

Some pharmaceutical manufacturers offer discounted or free prescription drugs for qualified individuals. This is most helpful with high-priced and specialty prescriptions. Reach out to the company directly, or search the database at **Medicare.gov** to determine drug availability and where to go for savings.

Retiree Qualification

As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C: Carrying of concealed firearms by qualified retired law enforcement officers. For example, if you qualified on May 1, 2022, then you must qualify on or prior to May 1, 2023.

The upcoming scheduled retiree qualifications at the Academy are:

- Wednesday, August 9, 2023, at 1300 hours
- Wednesday, October 11, 2023, at 1300 hours

Additionally, all retirees may also reach out to their local District Headquarters for local weapons qualification availability.

You must complete a Weapons Qualifications Record (HP-15C), that includes your personal weapon information, and submit it to Melissa Fellure at mjfellure@dps.ohio.gov no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition.
