Special Committee on COLA

Last month we reported the inability to provide a cost-of-living-adjustment (COLA) in 2025, and the creation of a Special Committee on COLA. The committee met for the first time on July 17. During the first meeting the committee reviewed the history of COLA provided to HPRS members, as well as the changes to the benefit over time. A committee work plan was established that provides the following objectives:

- Evaluate the current COLA framework and its impact on HPRS and its members.
- Evaluate the COLA framework at other retirement systems.
- Work with the HPRS actuary to determine the cost and impact of potential changes to the COLA framework.
- Propose legislative and/or administrative changes to the board regarding the COLA framework.

An update on the progress will be provided in the newsletters going forward and additional information can be found on our website.

Board News

HPRS received one candidacy form by the May 24, 2024 deadline for the employee-member trustee position. Per Ohio Administrative Rule 5505-9-01 (F), if the number of candidates is less than or equal to the

number of available board seats, each candidate shall be certified as a trustee without the need for an election.

Major Matthew Them is officially re-elected as employee-member trustee for the four-year term, August 1, 2024 through July 31, 2028. He will be sworn in at the August meeting.

Retiree Qualification

The Academy Range will be hosting annual retiree qualifications in 2024. As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C:

Carrying of concealed firearms by qualified retired law enforcement officers. For example, if you qualified on May 1, 2023, then you must qualify on or prior to May 1, 2024.

The upcoming scheduled retiree qualifications at the Academy for 2024 are:

- Wednesday, August 7, 2024, at 1300 hours
- Wednesday, October 9, 2024, at 1300 hours

Retirees may also reach out to their local District Headquarters for local weapons qualification availability.

You must complete a Weapons Qualifications Record (HP-15C), and submit it to Melissa Fellure at mjfellure@dps.ohio.gov no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition. Beware of These Common Types of Scams

Investment Scam

Scammers may reach out claiming to have a guaranteed, no-risk strategy to turn an investment into huge financial gains. These investment opportunities often operate through financial apps or websites that appear legitimate.

Employment Scam

When searching for work, people may come across fake job postings or be contacted by recruitment impersonators. These job offers typically advertise the ability to make money working from home with little time or effort needed.

Impersonation Scam

The scammer may pose as a business, government agency, or vendor you work with. They may send you a spoofed email (appearing to be from a legit source) or use a fake caller ID, requesting a change in payment or creating a false sense of urgency to send funds due to fraud or a late payment.
