Medicare Part B Excess Charges

Medicare-eligible members should be aware that doctors who do not accept Medicare assignment may charge up to 15 percent more than what Medicare is willing to pay. This amount is known as a Medicare Part B excess charge. You are responsible for Medicare Part B excess charges in addition to the Medicare-approved amount you already pay for a service. Part B excess charges do not count toward your annual Part B deductible.

For members that live in Ohio, this is not a concern as it is prohibited by law. However, only eight states have a law in place to prevent Medicare Part B excess charges. You can avoid the risk of Medicare Part B excess charges by making sure that the provider accepts Medicare assignment. Moreover, if you have a Medigap

Plan F or Medigap Plan G, Medicare Part B excess charges are covered. As a good measure, always ask the provider whether they accept Medicare assignment. For more information on this, go to https://www.medicarefaq.com/faqs/part-b-excess-charges-medicare-overcharge-measure/.

Many of you have not completed a Beneficiary Designation form since you entered the Academy. Your marital status and dependents have most likely changed since then. Upon your passing, Chapter 5505 of the Ohio Revised Code provides for the payment of survivor benefits to your spouse and dependent children. Wellness Incentive Reminder

Wellness programs are recognized as an important factor in maintaining your health. To increase participation in these programs, a reward was put in place in October 2020, for the completion of all eligible tests for the Comprehensive Wellness Exam (CWE) or Screening. HPRS is continuing this reward until further notice, which provides a \$100 VISA Gift Card for eligible participants that complete all applicable tests for the CWE or Screening. A reward is offered for both programs. Please allow 6-8 weeks after your exam or screening to receive the \$100 VISA Gift Card. A description of the programs are as follows:

Comprehensive Wellness Examination (CWE): covered once every two years. Includes: physical examination, comprehensive metabolic test, treadmill stress test,

body fat testing, and prostate specific antigen for men.

Screenings: covered once every four years. Includes: CT coronary artery calcium scoring, carotid artery ultrasound screening, abdominal aortic aneurysm ultrasound screening, CT lung screening (for current or former smokers only), and bone density screening (for members not eligible for the lung screening).

Retiree Qualification

As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C: Carrying of concealed firearms by qualified retired law enforcement officers. For example, if you qualified on May 1, 2021, then you must qualify on or prior to May 1, 2022.

The upcoming scheduled retiree qualifications at the Academy are:

- Friday, June 17, 2022, at 0900 hours (Retiree Cookout)
- Wednesday, August 10, 2022, at 1300 hours
- Wednesday, October 12, 2022, at 1300 hours

You must complete a Weapons Qualifications Record (HP-15C), that includes your personal weapon information, and submit it to Melissa Fellure at mjfellure@dps.ohio.gov no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition.
