Pre-Medicare HRA Project Update

As a reminder, the Pre-Medicare HRA project pertains only to the Pre-Medicare (under age 65) Health Reimbursement Arrangement (HRA) that will begin in January 2024.

An additional month of the Pre-Medicare HRA allowance will be available to eligible members in 2023, *for use on health care premiums only.* This additional allowance was approved by the board to help with the hardship that may result from paying 2024 plan premiums during the enrollment period in 2023.

As a reminder, open enrollment for those impacted by the Pre-Medicare HRA project begins November 1st and goes through December 15th. If you have access to medical and prescription drug coverage elsewhere and only need to opt-in to the HRA, you can do so online or you can call Via Benefits. This is <u>required</u> to ensure you have the HRA in place for January 2024. If you need medical and prescription drug coverage, please engage with Via Benefits now to get your appointment scheduled. It is important to consider discussing your situation with Via Benefits, as you may qualify for a Premium Tax Credit (PTC) or Cost Sharing Reduction (CSR). For some, choosing the PTC or CSR will result in less health care expenses than utilizing the HRA.

OSP 90th Anniversary - Camp Perry Ceremony

A note from Colonel Charles Jones:

In further celebration of our 90th anniversary, and with the support of the Ohio History Connection and Ohio Army National Guard, I am honored to announce the installation and unveiling of an Ohio historical marker at the location of the first

graduating class at Camp Perry in Ottawa County on November 15, 1933.

A ceremony to commemorate this very unique recognition of one of the most important moments in our 90-year history is scheduled for 1:00 p.m. on November 1, 2023, at Camp Perry, Hough Auditorium, Building #2, which is located at 2 Lawrence Road, Port Clinton, Ohio 43452. Attendees will also have the opportunity to see the new historical marker on the grounds at Camp Perry as it is unveiled on November 1st. Special thanks to the Ohio History Connection and Ohio Army National Guard for their partnership in making the historical marker a reality and participation in this event. Additionally, the Ohio State Highway Auxiliary will be at the event selling 90th anniversary merchandise. Patrol families and friends, retirees, as well as our law enforcement partners, are also cordially invited to attend this memorable ceremony.

Tax Update for 2024

On July 4, 2023, House Bill 33 was signed into law, which includes new state tax tables. The new tax tables will go into effect on November 1 and may affect your pension's net pay.

Wellness Program and VISA Gift Card

All retirees, spouses, and surviving spouses that complete a Wellness Examination or Screening prior to December 31, 2023, will receive a \$100 VISA Gift Card. The wellness programs will continue in 2024, but the VISA Gift Card will no longer be awarded to participants that

<u>Cybersecurity Awareness Month:</u> <u>Tips for Staying Safe Online</u>

October is Cybersecurity Awareness Month, a time to focus on the importance of protecting our personal and organizational information from cyberattacks.

Cyberattacks are becoming increasingly common and sophisticated. In 2021, there were over 623 million ransomware attacks worldwide, double the amount in 2020. These attacks can have a devastating impact on individuals and organizations, costing trillions of dollars in damages annually.

Below are a few steps you can take to improve your cybersecurity:

- Use strong passwords and change them regularly
- Enable two-factor authentication wherever possible
- · Be careful about what information you share online
- Keep your software up-to-date
- Use a firewall and antivirus software
- Be aware of phishing scams
- Back-up your data regularly

One of the most important steps you can take is to educate yourself about cybersecurity risks and stay up-to-date on the latest preventive measures.

Don't let a sales pitch cause you to enroll in the wrong medical or prescription coverage!

Members should expect to receive phone calls and mail from a variety of vendors offering medical coverage and services during Medicare open enrollment. In the past, retirees have reported receiving calls from people claiming to represent HPRS. Via Benefits is the only authorized representative that our Medicare-eligible retirees should hear from. As a reminder, to be eligible for the Health Reimbursement Arrangement the Medicare Health Care Coverage must be enrolled through Via Benefits.

2024 Dental Coverage Premium Change

Dental coverage premiums will increase in 2024. For retirees and surviving spouses, the premiums will increase to \$10 per month. The premium for a spouse or for child(ren) will increase to \$25 per month.

* Health Care service credit includes (HCSC): HPRS service credit, DROP participation time, purchased interrupted military service credit, and purchased or transferred OP&F service credit.

Disability Retirees:

- In-the-line-of-duty disability retirees receive 25 HPRS service credit, in addition to other qualifying credits.
- Not-in-the-line-of-duty disability retirees with 20 or less HCSC will receive the minimum HRA amount (61% of Base).

Surviving Spouses receive a HRA in the amount of \$350 per month in 2024.
