Use Caution During Medicare Open Enrollment!!

Don't let a sales pitch cause you to enroll in the wrong health care or prescription coverage!

Members should expect to receive phone calls and mail from a variety of vendors offering medical coverage and services during Medicare open enrollment. In the past, retirees have reported receiving calls from people claiming to represent HPRS. Via Benefits is the only authorized representative that our medicare-eligible retirees should hear from. As a reminder, only those that enroll in Medicare Health Coverage through Via Benefits are eligible for the Health Reimbursement Arrangement (HRA).



The 2025 open enrollment period is November 1st - 30th. Please submit a Dental & Vision Election form for new enrollment or to add an eligible

dependent. The form can be found on our website at www.ohprs.org, under "Forms". If you do not have any changes, coverage will continue as previously selected.

Termination of dental and vision may also be done during the open enrollment period. The Termination of Coverage form can be found on our website under "Forms".

Dental & Vision ID Cards

The HPRS dental plan is administered by Delta Dental for HPRS benefit recipients and eligible dependents. ID cards are not issued for dental coverage. You can print a generic Delta Dental identification card from Delta Dental's website at: www.deltadentaloh.com

Open Enrollment

Please review with Via Benefits which option would be best for you.

Retiree Qualification

The Academy Range will be hosting annual retiree qualifications in 2025. As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C: Carrying of concealed firearms by qualified retired law enforcement officers. For example, if you qualified on May 1, 2024, then you must qualify on or prior to May 1, 2025.

Upcoming scheduled retiree qualifications at the Academy for 2025 are:

- Wednesday, January 15, 2025, at 1300 hours
- Wednesday, April 2, 2025, at 1300 hours
- Friday, June 6, 2025, from 9 a.m. 10:30 a.m. (Annual Retiree Cookout)



- Wednesday, August 6, 2025, at 1300 hours
- Wednesday, October 8, 2025, at 1300 hours

Additionally, all retirees may also reach out to their local District Headquarters for local weapons qualification availability.

You must complete a Weapons Qualifications Record (HP-15C), that includes your personal weapon information, and submit to Melissa Fellure at mjfellure@dps.ohio.gov no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition.
