<u>Pre-Medicare Health Reimbursement Arrangement</u> <u>Project Update</u>

As a reminder, the Pre-Medicare HRA project pertains only to the Pre-Medicare (under age 65) Health Reimbursement Arrangement (HRA) that will begin in January 2024.

Via Benefits is currently placing calls to those impacted by the upcoming changes to HPRS health care benefits. Please engage with Via Benefits to schedule and complete your pre-enrollment appointment. As a reminder, it is important to consider discussing your situation with Via Benefits, as you may qualify for a Premium Tax Credit (PTC) or Cost Sharing Reduction (CSR).

If you do not qualify for a PTC or CSR, and plan to access medical and prescription drug coverage somewhere besides Via Benefits, you may only need to "opt-in" to the HRA. More information about the HRA opt-in process will be posted to the HPRS website soon and provided in the October HPRS newsletter.

Wellness Program and VISA Gift Card

All retirees, spouses, and surviving spouses that complete a Wellness Examination or Screening prior to December 31, 2023, will receive a \$100 VISA Gift Card. The wellness programs will continue in 2024, but the VISA Gift Card will no longer be awarded to participants that

Use Caution during Medicare Open Enrollment

Don't let a sales pitch cause you to enroll in the wrong health care or prescription coverage!

Members should expect to receive phone calls and mail from a variety of vendors offering medical coverage and services during Medicare open enrollment. In the past, retirees have reported receiving calls from people claiming to represent HPRS. Via Benefits is the only authorized representative that our Medicare-eligible retirees should hear from. As a reminder, only those that in enroll in Medicare Health Coverage through Via Benefits are eligible for the HPRS Medicare Health Reimbursement Arrangement.

Retiree Qualification

As a reminder, your qualification under the LEOSA rules is only good for one year from the date of qualification. This can be found in 18 USC 926C: Carrying of concealed firearms by qualified retired law enforcement officers. For example, if you qualified on May 1, 2022, then you must qualify on or prior to May 1, 2023.

The last scheduled retiree qualification for 2023 is: (PLEASE SEE LOCATION CHANGE BELOW)

• Wednesday, October 11, 2023, at 1300 hours - Orient Correctional Range (OSP Range #6), 11781 State Route 762, Orient, OH 43146

Additionally, all retirees may also reach out to their local District Headquarters for local weapons qualification availability.

You must complete a Weapons Qualifications Record (HP-15C), that includes your personal weapon information, and submit it to Melissa Fellure at <u>mjfellure@dps.ohio.gov</u> no less than 14 days prior to the qualification date. Retirees must bring their Division-issued ID Card with them to the qualification, and the retiree must supply weapon(s) and ammunition.
